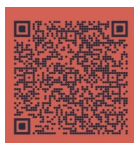

## New Wasatch County RAP Tax Opportunity

After a second try, and with over 1,200 more in support of the measure, Wasatch County residents voted to support a recreation, arts and parks tax. Heber Vally Chamber of Commerce Director Dallin Koecher estimates the tax could generate \$800,000 next year, with visitors to the County contributing about half of that.

With a heavy focus already on recreation in our area, Koecher said that the tax will provide a boost for the arts community as well.

The County is searching for board members for a new organization it will set up to allocate the RAP tax to communities throughout the County. (Now called the TAP tax; Trails, Arts, Parks.)

Having a resident of Hideout on the board could help our community be in consideration for a share of these tax funds.

## Notice of proposed Tax increase

The Town of Hideout (Town) is proposing to increase its property tax revenue.

The Town tax on a \$1,600,000 residence would increase from \$382.80 to \$409.20, which is \$26.40 per year.

If the proposed budget is approved, the Town would increase its property tax budgeted revenue by 6.86% above last year's property tax budgeted revenue excluding eligible new growth.

All concerned citizens are invited to a Public Hearing on the tax increase.
