Hideout Joins Wasatch Fire Dist. Groundbreaking



On September 18th Hideout staffers Jan McCosh and Timm Dixon were pleased to join the District in breaking ground for Wasatch Fire District's Hicken Station 51. In the center of Heber, the station will be the new Headquarters Station and house five Fire Fighters and EMTs each day Completion is expected in Spring of 2025.

Wasatch Fire District (WFD) Plans Two New **Projects in Hideout**



As Hideout continues to grow, so does the demand for better response time to hazards, disasters, and medical emergencies. To improve response times in Hideout, the WFD and Hideout are proposing a temporary living quarters and response vehicle in the existing Public Works Building.

The Town and WFD will need the community's help and support in fundraising for this project.

Town staff is also working with District Fire Chief Eric Hales on a new Wasatch Fire District Substation that will be located on the east side of Hwy 248 near the Klaim Development.

Topic: UDOT Issues

Noise on Hwy 248; Hwy 248 access road; trailers on Hwy 248; Brown's Canyon traffic light timing.

Topic: Taxes

Accuracy of recently appraised values and the methodology for assessing and collecting taxes.

Topic: County Services

Adequate services to the Jordanelle Basin and items specifically related to fire, Sheriff, road maintenance, snow plowing, and code enforcement.

Topic: Representation

Insufficient members of county boards and commissions have Jordanelle representation; many items raised that are subject to state control and require representation at that level.

The County's response to these issues is found in the document attached to this email.

Wasatch County intends to convene a meeting with Utah elected representatives in November and will distribute information once the date is set.
