Hideout POST Committee Partners with Jordanelle State Park to Seek Grant for New Multi-use Trail



On February 13, 2004, Parks, Open Space, and Trail (POST) Committee Members met with Jordanelle State Park (JSP) Manager, Jason Whittaker, to discuss the grant options for exciting new trail projects they hope to undertake in Jordanelle State Park.

The grant(s) will focus on these new projects:

1. One mile multi-use trail to parallel the road from the Park entrance gate to the boat ramp
2. Potential access points from Hideout trails into the Park
3. Updated signage
4. Maintenance of existing trails

Funding sources to match the grant(s) may include a contribution from the Hideout Town Budget, in-kind labor hours by community volunteers and equipment, materials, and labor provided by Jordanelle State Park. Additional community fund raising ideas are also under consideration.

The JSP Manager and Committee Members will review and walk the trails in coming weeks to determine which grants to apply for. Committee Members will be soliciting letters of support from Hideout residents to accompany the grant applications. CONSTRUCTION CORNER Subdivision Construction Update

Time for a subdivision construction update! This includes the water, sewer, and storm drain infrastructure construction of new subdivision phases in Hideout:

Deer Springs: Phase 1 was previously completed and accepted by the Town. Phases 2A and B have now been completed and accepted by the Town. Future phases have yet to begin construction.

Klaim: Roadways are complete for all phases. Crews are currently working on retaining walls. The developer is preparing all phases for completion and acceptance by the Town.

Lakeview Estates: The developer is preparing for completion and acceptance of all three phases by the Town.

Golden Eagle: Crews are working on retaining walls at the pump station and the new access road to the subdivision is paved. The developer is working on preparing Phase 1 for Town acceptance in the coming year.
