WATER QUALITY OF UTAH LAKES AND RESERVOIRS

The Utah Department of Environmental Quality/Water Quality monitors Utah lakes and reservoirs throughout the year and especially during summertime.

Currently the Jordanelle is clean and safe, along with Rockport, Smith-Morehouse, East Canyon, and Echo Reservoirs. Deer Creek Reservoir is under a Warning Advisory, which means you are advised to not swim or waterski and keep your pets away from the reservoir.
