Right-of-Way Excavation Permit Instructions and Application

Requirements:

1. Reference the entire Town of Hideout Code at <https://hideout.municipalcodeonline.com>. The section regarding this permit is Section 8 Public Ways and Property, 8.02 Excavations.
2. All trenches must be properly backfilled and compacted to 95% of maximum dry density (ASTM D1557). Applicants are responsible to conduct and coordinate compaction testing by nuclear moisture density testing for backfill within an existing or proposed roadway.
3. Asphalt or gravel must be placed to town minimums or original condition, whichever is thicker/greater. Final grade must match existing.
4. Any core holes, or similar within the paved surface of the roadway must be abandoned by filling with flowable fill and patched with hot mix asphalt at the required thickness.
5. Debris, grubbings, trash, or rubbish must not remain on site in any capacity after the project is completed.
6. Disturbed landscaping or native vegetation must be restored or remediated. Disruption of native vegetation and landscaping is inclusive of stormwater runoff, dust and spills.
7. Utilities must have an active Bluestakes ticket prior to and throughout excavation.
8. A plan set or map describing the work and its location must be submitted with this application.
9. If work is being conducted in the roadway, a traffic control plan must be submitted.
10. If applicable, a SWPPP plan and General Construction permit must be obtained from the state DEQ & DES for sites 1 acre in size, or greater. For disturbance less than one acre, a CPOD single family residence permit must be obtained.

Fees:

Per the approved Fee and Rate Schedule dated 1/15/2024, the following are the fees associated with an excavation permit:

- **Excavation Without Asphalt Cut Fee:** \$550.00 + \$1.00 per square foot of excavation.
- **Excavation With Asphalt Cut Fee:** \$500.00 + \$3.50 per square foot of asphalt over 25 square feet.
- **Noxious Weed Control Fee:** \$137.50 minimum fee up to one-half acre plus \$137.50 for each additional half-acre.
