Hideout Initiates Update to General Plan

On February 13, 2025 a press release by Langen Communications (representing the Town of Hideout) announced plans to update the Hideout General Plan.

"Since the adoption of the General Plan in 2019, Hideout has seen significant changes in population, housing, and



community needs. This update is an important opportunity to revisit our vision, set new goals, and ensure we're meeting the challenges of the future while preserving the character of our mountain town," said Philip J. Rubin, Mayor of Hideout.


The Town will gather community input through public meetings, surveys, and regular updates from the Planning Commission. "Our goal is to ensure that the updated General Plan reflects the collective vision and priorities of the people who live and work here," said Jan McCosh, Town Administrator.

CONSTRUCTION CORNER



Here's a Hideout Residence Construction Update:

As of February 12, 2025, the Town has issued 816 Certificates of Occupancy and now has 111 active Building Permits. This makes a total of 927 "Doors" in Hideout.

Many homes in Hideout are now over 10 years old, resulting in more inquires about remodel permits. The following information may help you determine whether or not you need a permit for revisions to your home:

Any revision to your home that requires structural, electrical, plumbing, or mechanical changes or additions needs a permit.

Structural changes could include walls, doors, roofs and decks.

Electrical and plumbing could include a bathroom, kitchen, water heater, furnace, hot tub, solar panels, EV charger, or generator.

Mechanical could include changes in a heating and cooling system such as a furnace or air conditioner.

To apply for a remodel permit, go to www.hideoututah.gov and click on "Permits and Licenses, then select "Building Permits" on the dropdown. Choose the first bullet point, "Building Permit Process" on the Build Permits page.

Changes that do not need a permit could include replacement or changes in interior finishes that do not require any other the items mentioned above.
