MAYOR'S MESSAGE by Ralph Severini

Hello fellow Hideout'ers and Greetings!



As you may know, on May 12th during a Town Council Special Meeting, I was appointed the new 2025 Interim Mayor of Hideout to replace Mayor Rubin who stepped down for health reasons. I am honored to have been selected to serve as your new Mayor and grateful for the trust the Council has placed in me. One of my priorities as Mayor will be to increase transparency and communication between the town government and Hideout's residents and property owners. To that end, you can expect more direct

communications and opportunities to connect with me in the future.

My plan is to publish a monthly message in the town newsletter. In these messages, I will update you on the important work we are doing in town government to help improve the quality of life in our community.

For those who don't know me, I'd like to share a brief bit about my background and family. When my wife Suzanne and I first saw Hideout

nearly nine years ago, we fell in love with the views and sheer beauty of this area. Our daughter and her family live close by, near the Retreat at Jordanelle, with my eight year old grandson and son-in-law. My daughter Vanessa is a teacher in the Park City School system and my son John is now nearing completion of his PhD at Georgetown University. Since 2018, I've been a member of either the Hideout Planning Commission or the Town Council, as well as Chairman of our Economic

Development Committee and co-chair with Councilman Jonathan Gunn on

our Wildfire Committee. This is the third town I've served on Planning

Commissions or Economic Development Committees for over the course of my life. My plan is to work with the Town Council, various committees and commissions, our staff, our residents and surrounding neighbors to further the vision and goals of Hideout. We will be reaching out to the community by way of an open house and surveys as we update our original 2019 General Plan to accommodate the Silver Meadows (Richardson Flat)

The following are some of the major items that I have worked on as Town Councilman and plan to continue prioritizing as your Mayor:

Completing our vital water study.

annexation into a connected and vibrant community.

- Continuing to work with the Silver Meadows Annexation; a prime source of revenue for the Town providing a place to shop and dine.
- Continuing our efforts on the Ross Creek site to bring recreational retail and additional open space that the Town controls including acquisition of lands in a public-private partnership. This area could also easily support a community center and recreational area for Hideout given its central location.
- Working to make our town, streets, and SR 248 safer.
- Protecting our viewsheds and keeping our property values high, while continuing our efforts for open space, trails and recreational amenities.
- Building a firewise community to protect us from potential wildfire dangers and keep property insurance accessible and affordable.
- Maintaining fiscal responsibility including optimizing our sources of funds including more grant writing.
- Being more of a regional participant and force by building bridges to our surrounding communities with the hope of more cooperation and fewer disputes.

Lastly, I want to create more transparency with our residents. To that end, I will also be initiating the "Mayor-hour" where residents can schedule a 10 minute call with me to discuss their ideas, input, and hot topics. I'm doing this because a number of my neighbors have said that they simply can't attend the Thursday evening monthly Town Council Meeting. So I will be creating another avenue for open communication.
