Mayor's Message

Hello fellow residents of Hideout,

What a great time we all had on Friday September 12th at the town concert! The Discographers' performance was fantastic, the dance floor was lively, and the food trucks were delicious. We look forward to more events like this. Thank you to the volunteers on our Hideout Events Committee for all you do to build community and connection for our town!

The area around our maintenance building, with

its stunning views of the Jordanelle and Deer

Valley East Village, holds incredible potential for our town. Hideout owns three parcels in this vicinity which are prime for recreational amenities and light commercial development, such as restaurants. We are actively exploring publicprivate partnerships to bring this vision to life. While attracting commercial developers remains a challenge, the town and the Economic Development Committee are committed to finding the right partners for this exciting opportunity. We are addressing a safety issue at the entrance to Ross Creek and the Jordanelle Park from SR-

248, where high-speed traffic endangers drivers. I am currently asking UDOT to improve the poorly designed right turn lane. Because UDOT prioritizes 4-way intersections for new stop lights, Hideout will eventually move the Shoreline/ Longview road to connect up with Deer Mountain Blvd, so it will become a 4-way intersection. To accelerate these safety improvements, I am circulating a petition which will focus on adding safety features now before a major accident occurs. If necessary, I will take this to the Governor for action, which UDOT reports to. We are hoping to gather at least 500 signatures to help send the message that this is a topic of serious concern to our community. Remember that your vote is your voice and the Governor will listen to both. The last item is a reminder that I hold open office
